- The licensee must have available for consumption on the premises, a reasonable range of non-alcoholic beverages, at all times when the premises are open for the sale, supply, and consumption of alcohol.
- The Licensee must display signage as follows:
  - a. At every point of sale/supply detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons; and

## DECISION DETERMINED ON THE PAPERS

This is an application for a Special Licence under section 22 of the Sale and Supply of Alcohol Act 2012.
