#### 5 DECISION REPORTS FROM CHIEF EXECUTIVE AND STAFF

# 5.1 GREYTOWN WATER SUPPLY SERVICES DELIBERATIONS

Mr Corbett introduced Mr Trafford, who has recently been appointed to the role of Principal Engineer – 3 Waters.

Mr Thomas, supported by Mr Mattsen and Mr Edwards provided a summary of the process up followed up to the point of today's deliberations to support members in making their decisions in relation to this matter.

Members queried the noises affecting campground and how this would be mitigated in future, as well as future dampening work (noise levels of underground tank noted to be less than current above ground tank); water storage and future-proofing of supply; back-up generators; the life span of the bore (up to 100 years) and it's seismic resistance (this moves with the ground); and the number of respondents to the consultation questions living outside of Greytown (17).

Members acknowledged Wellington Water's answers to the questions raised at the hearings.

Members also queried the option to keep the current bore and upgrade the pump system only. Mr Lawrence noted that the proposal was to continue to use the bore, replace existing pump and noted that a new plant cannot be commissioned without a new bore. Noted that Wellington Water will make efforts to scale down the physical and visual interference of the equipment as much as possible.

The Strategy Working Committee resolved to request that council officers, in collaboration with Wellington Water, report back to the Strategy and Working Committee on the final design which takes into consideration the following consultation feedback and to fulfil Sections 39, 40, 41, 42 and 43 of the Soldiers Memorial Park Management Plan August 2007:

- (a) to finalise the location of the bore and a design that avoids the memorial plaques and is sympathetic to the natural/cultural heritage of the park;
- (b) finalise the design of the Water Services Infrastructure next to the pool that is in keeping with the natural/cultural heritage of the park and surrounding buildings;
- (c) confirm that the bore and water services infrastructure will have sufficient sound proofing for the quiet enjoyment for users of the park and the campground;
- (d) receiving an updated timing and schedule of works;
- (e) consider the need for an updated assessment of the impact on cultural heritage sites, trees and amenity values (*including the pool*), historic values, buildings, turf and paving and how these are to be protected; and
- (f) confirm the restoration of sites not used after the completion of work back to a park.

- 3. note that following the consultation process and in accordance with section 24A of the Reserves Act 1977, that the Council is not intending to change the purpose of Soldiers Memorial Park.
