We are concerned that you are expecting the rural ratepayers to pay for services that we do not benefit from.

1. Three waters. Yes you need to get these upgraded and it should be user pays.

It seems unbalanced that Council does not provide any of the three waters services to those living in the rural area but expects the rural ratepayer to contribute to the upgrade of these services to the urban ratepayer and residents.

2 . Rural Roads. Yes we need more seal and happy to contribute on a 50/50 basis increase in rates, as urban drive on these roads as well.

3. Footpaths. You are proposing the rural ratepayer pay 1.03% and urban ratepayers only 0.34% for new and R and M of footpaths. This seems unfair.

Please note we have interpreted agree as being Option 1 for each decision and disagree as Option 2. Assuming this is what was intended, we feel that it could have been much more clearly labelled, and so avoid confusion.

Also we query whether the Council should be making final decisions around the three waters (and associated rates rises) before the Government announces its policy on three waters reform.

Decision 1: We disagree as we back option 2. We feel this is critical infrastructure and we need to bite the bullet.

Decision 2: We are neutral. However, we feel that in special or exceptional circumstances this should be given consideration upon request.

Decision 3: We agree although we feel it is important to us a cohesive and attractive design. For example, we don't feel the new pavement in Esther Street particularly enhances the look of the Street, whereas other streets where the pavement runs at the side of the road look more aesthetically pleasing.

Decision 4: We agree. However, we would query what would happens in roads such as Ferry Road, where one side of the street is rural, who would be responsible for the rural side, particularly in cases where the berms are so uneven that they can't be cut with a domestic mower.

Decision 5: We are neutral. If the Greytown community is strongly behind this option should they be required to match any funding the SWDC puts into the scheme.

Decision 6: We disagree. In order to ensure people recycle there is a wealth of research that demonstrates you need to make it easy. Not only does pushing residents to Featherston make it harder (and therefore recycling rates will drop) but it also has other negative environmental impacts in terms of increasing emissions (i.e. our carbon footprint) from private vehicles, as well as potential fly-tipping.

Could a compromise be considered by installing a skip-style container recycling bank which could accommodate all recycling and 'council bagged' landfill rubbish (i.e. the yellow sacks), whereas any other landfill would be directed to Featherston.

Berms

I understand that around 70% of residents mow their own berm or arrange for a contractor to do so. The Council's contractors mow infrequently and do a poor quality job. There are many elderly residents and others who are not physically capable of mowing. Corner properties can have two berms some of which can be in excess of 240 sqm and really need a ride-on mower. I suggest a register be kept for those unable to mow and that the council be responsible for mowing these, after all the berms belong to the council.

West St Development

These should only be implemented once the water supply networks in our towns have been repaired and all the leaks in the network repaired. This is an extra cost is not justified.

I am in favour of skateparks in general, but I strongly disagree about this proposed skatepark in a built-up residential area at 4-6 Pierce Street.

If you look at where the greater Wellington region skateparks are located, all of them are within or adjacent to parks or located away from residential areas and for very good reason. This applies to the Featherston & Masterton skateparks which are located in the commercial area next to SH2 and Queen Elizabeth Park respectively.

I spend half my time in Greytown and in central Wellington where I live near the Chaffers Skatepark opposite New World near Courtenay Place. Skateboards are noisy particularly when they flip their boards or try running the boards across a seat or smooth metal surface. Because the area is well lit the noise from skateboards continues into the night along with loud music that goes with the skateboard fraternity.

There are 55 sections being developed at Tararua Junction. All of Tararua Junction has been pre-sold. Along with the residents surrounding 4-6 Pierce Street and around the south end of West St and Cotter St all of whom will be affected by noise which will be particularly annoying in the school holidays, weekends and in the evenings when skateboard parks are used the most. Light pollution is another factor particularly as we want to encourage dark skies in South Wairarapa with reduced lighting.

It is obvious that the pamphlet produced by Sid Kempton and Jackie Gray and titled "Greytown Wheels Park" is simply spin for a Skateboard Park. They know it is a difficult proposition to build in a built-up residential area where ratepayers will be expecting quiet enjoyment. The frequently asked questions section in their pamphlet throws up more questions rather than answers. In fact, several years ago the residents of Kuratawhiti Street opposed a skateboard park in Soldiers Memorial Park for most of the reasons stated in the pamphlet. Do not shift the problem from one end of town to the other.

I would like Council to investigate other sites within Greytown for a skatepark that is located well away from residential ratepayers. At the very least an Environmental Impact Study report should be commissioned and then discussed with all the affected ratepayers surrounding Pierce Street and the new residents of Tararua Junction, most if not all will have no idea of the proposed skatepark opposite them.

Recycling Centre - I agree with closing down the Greytown recycle centre but only on 2 provisos (a) that an alternate local greenwaste dumping centre is opened so that we don't end up with garden waste and weeds being dumped in riverbanks, bush and ditches etc (b) that some of the existing space is used as carparking to service the playspace, rail trail and dog park. noting at present it is sometimes congested at the start of the rail trail due to too many cars blocking access for cyclists.

Playspace - please proceed on a priority basis. Please ensure that the space is maximised for activity not carparts by using the recycling centre land for carparking instead. Please provided good safe crossing space for people walking between the carpars, dog park, rail trail and playspace and that foot and cycle traffic has priority over vehicle movement. Please also provide a space for a coffee cart and or food trucks so that adults have incentive to hang around too!

Access Issue - I understand that there may be a roundabout at the Bidwill Cutting junction at SH2 south entrance to Greytown. If this proceeds please open up the short stretch of unformed road at the South St/Pierce St/Tararua Junction area so that traffic can channel in and out without going through local streets. This would help with safe walking and cycling access to the playspace etc especially if a walkway/cyclepath is dedicated from Pierce Street into playspace.

Also, if the roundabout proceeds please ensure Waka Kotahi are aware that this area is the only reasonably easy east to west crossing along Main St for cyclists as the current Stop sign position allows for good visibility and a short distance to cross to the alley way by the unformed road on the other side. Other parts of Main St are challenging due to poor sight lines and wider distance to cross along with traffic volumes.

Three waters - I support the investment in our infrastructure but will find the rates increase a challenge. My home is on an average section but lower overall value than many of the large new houses being built and therefore I also support future review of our rating structure to capture overall value as a better indicator of rates affordability. Also agree with smart meters. SWDC could help with a rainwater tank purchase payment plan via rates too.

Berms - I'd like to see a street ownership scheme where street residents are given a framework to choose how their St is managed. This would include some choice over street plantings e.g. community vege patch and opportunity to close their st for a street party or market 1-2 times a year. I've lived in places where this is a fun way to strengthen community connection. Residents would be responsible for managing and the council would no longer maintain the berms.

#3 - The proposal is to build new footpaths, curbs and channels in the urban area as a rural resident I only use the existing footpaths in the CBD of the SWDC towns. The proposal is for a general rates increase, this is not fair towards rural rates payers as we won't use urban footpaths not in the CBD.

#5 - I don't disagree with the proposal to build a play space, I disagree with the timing. You proposed to reduce services and save money by stopping rural road sealing, stop mowing berms and closing the Greytown recycling centre but you want to spend \$1m to build non-essential infrastructure, and neglect share the anticipated increased cost to maintain the play space. The timing is not right to implement this.

#6 - The recycling centre is located in an industrial zone on the district plan. Smells and vehicle movement is to be expected in the area. If there is a proposal to rezone the area, I will support a proposal to relocate the facility. Closing this centre is a reduction in services, and the adverse effect should be considered. Some people are only willing to recycle if it is convenient for them to do so. If you remove the convenient option, rubbish dumping and burning may increase. Your LTP document state, "rural residents, needing to drop-off recycling also have rubbish to dispose of, so tend to use the Martinborough Transfer Station". Is this fact based on research or based on an assumption and possibly misleading the public when you ask them to make factual decisions? We home compost, make environmentally conscious decisions when shopping, and generate the equivalent of one rubbish bag every five weeks. We do, however, recycle every three weeks. Surely we are not the only rural rate payers doing this.

General - Schedule of prospective capital expenditure 30 June 21-31 - Without access to the detail of the below expenditure, I question if the below is wasteful expenditure:

\$101,856 library books - I don't suggest we shouldn't buy books, but with the financial pressures we face, is there a saving here? We have access to books across the country through interloans, and e-books are readily available. Is this the right level of capital investment?

\$51,050, toilets - this is capital expenditure, not operating cost. Either Council is being taken for a ride by a contractor overcharging for minor repairs, or we are replacing toilets at an alarming rate.

\$459,658 other minor works - besides for cost associated with three waters, this is the third biggest capital expenditure. It deserves to be broken down to allow transparency over what is included in this.

Prospective Statement of Financial Position 30 June 21-31

The value of our investment properties is \$11,696,442,000 (the column header indicate the values to be in thousands "\$000", this doesn't feel right).

If the value of investment properties are \$11,696,442, short term deposits are \$11,252,520 and investments are \$508,298, we hold total investment of \$23,457,260. This excludes Property Plant and Equipment, which I assume include the properties used to deliver public services. Our cash flow was \$109,000 from investments, which is a return of .46%. Conservative property investment should be returning around 4-5%. At 4% we are missing out on \$829,290 per year. Are our investments being mismanaged? Revenue and Financing Policy (RFP)

Amenities

The private/public benefit varies greatly. As pools, parks, and reserves are by far the biggest expense of this activity, the private/public cost split should be 20-40% / 60-80% as per the RFP. The funding impact statement for amenities indicates \$51,000 of the \$4,157,000 revenue comes from fees and charges. That is 1.23%, nothing close to the 20-40% required under the RFP. Adjust the RFP to reflect reality or increase (introduce) charges.

I didn't do a deep dive into the publicly available information, and the above are just a couple of obvious examples of areas I believe Council is not managing our funds appropriately or reporting incorrectly or have an outdated/misleading RFP. This doesn't give me confidence in the current management of public funds. It might be worth appointing an independent financial expert to review our finances and make recommendations to improve efficiency and increase revenue.

1) There is a need to relocate the Cotter Street recycling station. There are several drivers for this:

a) The expansion of the town and it's amenities has to continue to be on the sides away from the Waiohine floodplain. This includes the south and western flanks of the urban area. There has already been considerable expansion in this direction with Tararua Junction and Governor's Green being significant anchor developments. Moving the recycling station away will help encourage this.
b) The establishment of the dog park and the rail trail have made this location quite important as a hub for recreation, exercise and amenity. Freeing up the land occupied by the transfer station would offer the opportunity to add a considerable greenspace, perhaps a children's playground and a car park to the amenities hub. Many families use the dog park and rail trail and these would combine well with a play/adventure space and greenspace.

c) A new location should be found beyond the edge of the urban area for a transfer station, a considerable area on the Greytown floodplain is unsuitable for urbanisation due to the floodplain, perhaps investigation of finding a site in those directions would be practical. WAG have worked with GWRC to develop a very detailed knowledge of the sensitivity of Greytown environs to flooding and may be able to help with this investigation.

d) Setting aside a portion of the freed up land from the transfer station for sale for housing would create a fund for the establishment of a new transfer station, which might be able to be achieved in a cost neutral manner.

The second submission relates to the need for greenspace.

WAG is working with GWRC Land Management and Flood Protection departments in the long term plan to restore and develop the whole Waiohine corridor and buffer zones. This work has already commenced - see the clearing of many acres of space at the end of Kuratawhiti Street for trails, park, amenity and recreation amongst carefully planned native plantings, with easy access points to the river. Within the plan, cycle, walk, swim, kayak, fish, nature watch, exercise, picnic and play areas and amenities are planned in a vast area of great natural beauty and rare, pristine water quality. Access to the river amenities from Greytown will occur in six different places, some within walking distances from the centre of town.

This work is being planned within the groundbreaking and comprehensive Waiohine River Plan, Incorporating Floodplain Management plan. All stakeholders are participating: SWDC, CDC, mana whenua, iwi, F&G, F&B, landowners, community groups (such as rail trail organisations) and so on.

Would it not be extremely cost effective for SWDC and the community to leverage this heavily within the SWDC LTP as it will become: 1) a significant tourist attraction,

2) add a greenspace that will exceed all other council greenspaces in and around Greytown combined,

3) an area of cultural and recreational significance,

4) a tourism and economic asset - how many large rivers in the lower north island feature extensive access to pristine quality water year round?

5) an area of outstanding natural beauty and

6) a major contribution to the restoration of a naturalistic corridor from the Tararuas to the town that will be teaming with flora and fauna.

In a time when, for many good reasons, money is tight, why not enhance, maximise and link up with a huge, beautiful greenspace that already belongs to the community, already on your doorstep and walking/cycling distance from the main street?

We would be very happy to provide a guided tour of the river corridor and discuss how this could be better understood with easily improved links to the town and environs.

I believe the site chosen for the skate/wheels park is totally inappropriate for the following reasons:

Nowhere from Masterton through to Wellington if you look on satellite googlemaps is ANY skatepark located within sight or sound of residential dwellings.

In addition, they are all part of a greater park that either abuts sportsgrounds or other recreational facilities, that in no measure represent a handkerchief portion of land.

Greytown is an area of low crime. Locating this park in an area that is no way monitored by the GENERAL public specifically during the times when it is not in use by genuine park users is just creating an opportunity for it to occur e.g. It is secluded. There will be limited lighting, road parking is being supplied which gives an opportunity for young people to congregate in their cars at night with no chance of being observed by road patrols or road users that are other than immediate neighbours at the new Tararua Junction subdivision, most of whom have not been enlightened about this proposal as many purchasers live out of area.

Councils are supposed to apply the SIPTED principals in town planning. This hasn't applied in this situation as the only plan shown as an example is one for the skatepark at Maidstone in Upper Hutt.

The location is a gift to Kuranui College students who now have an opportunity to truant and gather.

No doubt the lighting, public toilet locations will be of concern to those living across the road.

Whether it's PC or not public toilets are often used for sexual meetings that should have no opportunity in an environment where children and families are supposedly hanging out.

It is short sighted and a tick box exercise.

The skatepark should be located in an area ENTIRELY public where drivers by from different localities can make use of it as an opportunity to have some pause in long journeys etc.

The access is another issue - any emergencies mean Police/ambulance have to negotiate judder bars with no footpaths on one street, and footpaths only on one side on the other. The access is a dead end and means they have to pass AT SPEED through narrow residential dead end streets to provide a service. West street virtually has a blind corner down the end which is another hazard. Either place it where the existing layby is opposite Oak Park Motel or maybe consider purchasing land on Kempton's Line (think big!) that would be sufficient for sports grounds/sports complex AND a park that abut with the parks from Kuranui College. There is already a side lane/road by Country Traders for added access.

It is then accessible for all, visible for all and has the collective guardianship of ALL the public, not just a handful of residents at Tararua Junction.

There are no teenage issues for Greytown, so why make opportunities for those not engaged to loiter and intimidate. This absolutely does happen as I can confirm from 23 years of previous policing - intimidation, little children and families being bullied, theft ex-cars, teenage fights, noise from car exhausts.

Have a skatepark, we need one, but in the context of a greater public area.

Lastly, the average age for males in Greytown is 51. Given that only 3% estimated are users (USA stats where it's very popular) the amount of regular users is likely minimal. Yes the population is growing, so accommodate it intelligently in a place where whole families can use the adjacent parks and amenities.
