Big decisions 1: I agree to decision 1 based on adequate investment is made and prioritised for Featherston. To me, option 1 does not commit to the same level investment in Featherston as the other 2 towns.

Big Decision 4: I agree to this based on the condition that there is a fund set up for people in the community that will not be able to mow the berms. These might be disabled, kaumatua and kuia etc. Otherwise a berm being mowed will only be accessible to the privileged.

Big decision 5: I am neutral about this. Why has the prior investment into Featherston not being completed?

Big decision 6: I am neutral about this. Where will Greytowns recyclable products go to? Is there a plan for another space in Greytown to be created to cater for this? Or will the rubbish from Greytown become the responsibility of another town? Who will pick up the costs for this if rubbish is diverted to another town? This plan does not have enough detail, the options that are being looked at, the costs of those options, and who picks up the costs must be made transparent.

Another issue that i wish to speak about is affordable housing/social housing/kaumatua and kuia flats. With inflated house costs we are seeing gentrification of the South Wairarapa. This has huge implications on mana whenua and tangata whenua who have had land removed from them as an intended consequence of colonisation. SWDC must ensure that tangata whenua, mana whenua, kaumatua, and our most vulnerable of people have accessibility to warm affordable housing. I would like to propose that SWDC commits to 1. keep the kaumatua kuia flats affordable. 2. the kaumatua kuia flats are maintained and putea/money is set aside to ensure that they are living in warm and well maintained flats. 3. I would like SWDC to commit to the establishment/investment into homes that have a portion set aside for social housing, first time home owners, disabled and kaumatua kuia. We cannot turn a blind eye to providing this basic need to the peoples of the south wairarapa district.

I am also concerned with the proposed rise in rates, post covid this is almost cruel to enforce such high rates. Also the costs of rubbish bags (yellow ones) and the proposed rise in cost will possibly cost the council more in 'having to clean up or pick up rubbish that is dumped in our streams, rivers, at the freedom camping site. We must rethink this and look at alternative options to the one being proposed.

To SWDC LTP

From John Whitby / Star Field

29th April 2021

I strongly disagree with the SWDC preferred option to stop funding rural road seal extensions to minimise rate increases.

This SWDC preferred option could in fact lead to Rural health problems and the loss of a valuable Dark Sky Reserve initiative in the Ruakokoputuna area.

Approx 4 years ago I was looking at purchasing a block of land on the Eastern outskirts of Martinborough to develop an astronomy observatory complex under the dark rural skies.

This was after an exhaustive search throughout New Zealand over the previous five years for a dark site with a suitable number of clear nights.

I identified a 4Ha block 1.15 Km down the Ruakokoputuna Rd.

This was the first block available of a five block subdivision being carried out by Gavin Morison.(the Horse Whisperer)

However I was reluctant at first as there was a real dust issue from the unsealed road, due to the constant NW winds. I deliberated for several months and eventually asked the SWDC if the Ruakokoputuna Rd was going to be sealed in the near future. I had a verbal response that it was on the long term plan and would eventually be sealed.

This gave me the confidence to purchase the property and build the complex.

In the following year I put a submission into the Long Term Plan asking for the area outside the Morison subdivision (approx 300m) to be sealed, based on the health risk from continually breathing in the dust and dust contaminating expensive observatory equipment. The SWDC sent me confirmation that the sealing was now on the priority list.

The following year a new submission was sent in from a group of Ruakokoputuna residents ( which I was not part of) and from that the SWDC issued a three stage plan to seal the first 4km of Ruakokoputuna Rd over the following three years. Please see attached map: Mustard Stage 1 in 1st year (now completed)

Blue Stage 2 in 2nd year (Including the first 1.15Km of Ruakokoputuna Rd which would also include our 300m frontage)

Red Stage 3 in 3rd year

I was personally unaware of this SWDC decision until the marking out of the road on stage1 actually started.

At this point I approached the SWDC Roading Manager to question the order of sealing. I asked for the first 300m of straight road in stage 1, where nobody lived, to be transferred to the road outside the Morison subdivision where five families are suffering from continual dust pollution.

I was told verbally that the money was being spent on the highest maintenance parts of the road and several dangerous corners approx 300m further on from the Morison subdivision. The first 300m of newly sealed road is a straight section of road and fronts a new subdivision currently underway, where no one lives yet and won't be for a long time.

It seems the SWDC has put the cost of maintenance above the health of families. The same families that are now living on the subdivision the SWDC had approved just a few years prior!

It is obvious to me that the SWDC have not carried forward the 'Priority List' from the previous year or this would never have been allowed to happen.

To add insult to injury the SWDC are now seriously considering stopping all rural sealing programs including stage 2 & 3 of the Ruakokoputuna Rd, so now there is a real possibility that our section of road will never be sealed!

Now I am really questioning the integrity of the SWDC....

Apart from the constant appalling physical state of the road conditions which include deep potholes, rocks and exposed clay, the dust issue is affecting my own personal health as I have had lung damage from a Pulmonary Embolism, making breathing difficult in my retirement years. No doubt the other four families with young children that are my immediate neighbour's will also be experiencing health issues in the future from constant dust exposure.

I had in good faith committed to building Star Field on my property, Star Field being a substantial observatory complex currently used by the Wellington and Wairarapa Astronomical Societies and amateur astronomers from all over New Zealand. Star Field is a leading initiative in the development of the Dark Sky Reserve and has already contributed heavily to the accreditation process.

Currently there are six (6) observatories in various stages of planning and building on the site.

I personally have two observatories fully built and another under construction. These are for society and public use as well as outreach programs and deep sky astrophotography.



## Long Term Plan 2021 - 2031 Feedback Form

There are currently two (2) private observatories under construction, one almost complete plus the Wellington Astronomical Society have just approved \$150,000 towards a remote observatory onsite for their members use, they are about to break ground on that project very soon. These observatories will be used for public outreach, Science and deep sky astrophotography.

Each observatory can have tens of thousands and upwards of hundreds of thousands of dollars, worth of delicate equipment inside. This equipment is severely compromised by dust!

Every party involved at Star Field has had my verbal assurance that the dust issue was being taken care of in the near future, in fact this time next year, according to the SWDC! Now what will I tell them?

Star Field already has a Resource Consent to operate an Astro Tourism business on the site and that could take effect again some time in the near future when Covid is under control and we have access to overseas tourists again.

If the 300m of road outside the Morison subdivision is not sealed it will put the future of Star Field in serious jeopardy.

It would be a terrible shame to lose such a valuable facility, especially in light of all the research and work that has gone into the project over the last four years to establish a facility that is seen as the leading initiative to the Dark Sky Reserve.

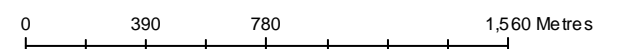

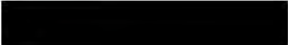

I write to make a submission to the Long Term Plan 2021-2032.

Under Challenge: Spaces

Page 8 of the Consultation Document

- This is a personal Submission, endorsed by the Martinborough Healthy Community Friday Walking Group. This initiative won the Minister of Health's Volunteer Awards in 2019.

It is my contention and recommendation that in Martinborough we badly need at least one scenic dedicated walking path protected from traffic. Thinking ahead, this could be the foundation of a network of easy walking routes, with more to come as residential growth and tourist numbers increase steadily and significantly as forecast.

- As mentioned in the Consultation Document, exercise and social wellbeing are increasingly cited as healthy for our ageing population. Crucially, this also expands our offering to visitors, so that we are not focused only on wine and food experiences. The relaxed beauty of our town is a significant asset, and the current popularity of cycling can be complemented by more - and safely separated - walking opportunities.

- The Mental Health Foundation found in their 2018 study that spending time in nature each week made 95% of people feel good. After Covid-19, what could be better as a green prescription?

- I belong to the Martinborough Healthy Community Friday Walking Group. In three years, our numbers have swelled from 8 to 25. Meeting in the centre of the village every Friday Morning, we walk for one hour. Recommended by the Martinborough Medical Centre, this initiative meets both physical and social objectives, for exsiting and new residents.

- Our route often includes walks alongside and sometimes (with permission) through vineyards, but invariably we find ourselves on roads with no footpaths, where we are too close for comfort to 100kph road traffic. Princess, Puruatanga, Huangarua, Regent and Cambridge Streets are immediately obvious examples. Cyclists face similar challenges.

- My long-term vision endorsed by walking group members, is for a comprehensive network of readily accessible, properly separated walking trails, ideally with properly formed surfaces. Such a network could ultimately extend from the Rapaki Walk to the Ruamahunga River, allowing visitors and locals alike safe spaces for family walks, with perhaps a picnic spot near the river. This, in a nutshell is what we are asking for!!

In summary, we recommend a long-term programme to provide:

- access to walking opportunities in our natural surroundings
- safety for walkers by removing 100kph traffic from the mix
- offer these walking paths as another tourist offering for our town as well as serving our townspeople.

Additional feedback to 6 Big Decisions:

With a limited revenue and budget, Council have the conundrum within the LTP of going for the biggest and easiest outcomes first. I provide these comments below to support my response to the Six Big Decisions. There is a big difference between fiscal prudence (by keeping rate increases to a minimum) and the maintenance of amenities for the common good to keep ahead of the deferred maintenance conundrum.

1: Three Waters - Resilience of water network: These are community essential assets necessary for life and consequence of failures are high (ie the problems in Wellington created by maintenance deferrals). Unless Council 'bites the bullet' and makes a positive decision to keep ahead of the problems surrounding the Three Waters we shall always be chasing our tail. The community requires these services to be to a high standard. Improvements now will enable long run efficiencies.

2: Rural road seal extensions: I believe Council should maintain a policy of continuing to seal rural roads based on a policy of partial recovery of costs by the benefiting of ratepayers involved (ie a targeted rate). The arguments supporting this programme hinge around safety for the road user and access levels of service for local dwellings.

3: Kerb and channel extensions: New town footpaths, kerbs and channels (and their upkeep) are important for pedestrian safety and I see it as essential to extend this network. The impact on urban rates of 0.34% is minimal, so why bother to neglect this amenity?

4: Mowing of accessible grassed berms: Berms separate residences from the road and are legally Council owned but it is predicated that the property owner or resident of the section will maintain them. I strongly support the policy of Council maintaining a berm mowing policy. My support is based around having Greytown recorded as being a 'tidy town'. Council should be more vocal with requesting residents to maintain their berms as they benefit from a tidy frontage (and emphasizing the support avenues available to elderly residents). The mowing of rural berms is quite simply a safety issue (visibility) and should be maintained on a cyclical basis.

5: Development of a Greytown play space: This project has continually been deferred. As there is no impact on rate increases, do it now as it is low hanging fruit. This will be an amenity improvement for an important sector of the community.

6: Greytown Recycling Station: Recycling stations are symbols of sustainability efforts by the community. The kerbside collection of small amounts of waste and recyclable material is now a common feature but I strongly believe that we should retain a recycling centre in Greytown for larger amounts of material and the existing site should be improved. The present facility is abysmal, especially for depositing green waste in winter, where there are pools of water in the dumping area. Council has a cheek to charge \$15 for a trailer of green waste. It is also of a poor design caused by the land area constraints. The existing site (or a new one locally) should be refurbished, redesigned and relaunched as a community asset. The design of a space to facilitate, support and encourage material and waste recycling by households is crucial. The options for driving longer distances to Featherston or Martinborough are unpalatable. Recycling is part and parcel of community existence and is central to sustainable urban development. The prerequisites for material recycling are continually changing and Council must keep up with this and not remove an important amenity. This ratepayer would be happy to pay an additional 0.4% on my rates demand providing the amenity is maintained and refurbished.

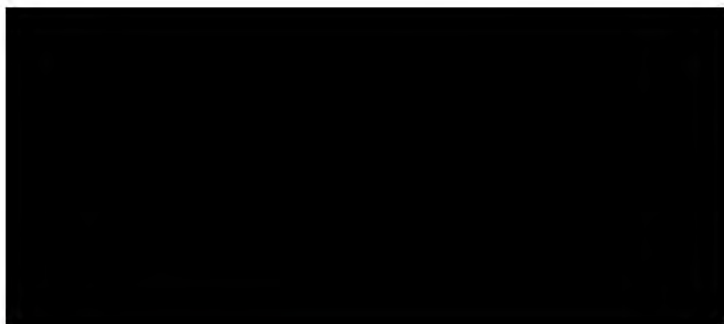

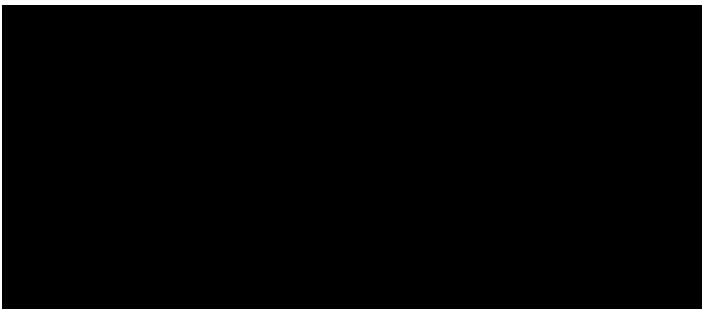
