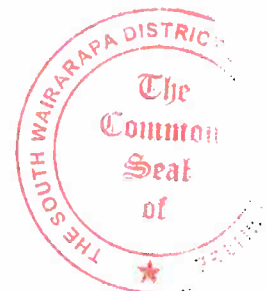
A temporary authority is granted in respect of the **Off Licence** issued in respect of the premises situated at **192 Regent Street, Martinborough** and known as **Dry River**.

DECISION ON THE PAPERS

This is an application by **Dry River Wines Ltd** for a Temporary Authority in respect of premises situated at **192 Regent Street, Martinborough** known as "**Dry River**".

REASON FOR DECISION
